

*How Much Is That in Real Money?
A Historical Price Index for Use as
a Deflator of Money Values in
the Economy of the United States*

BUT how much is that in *real* money? It is a question that lurks behind the mention of the price of anything in the past, from the cost of George Washington's false teeth to the worth of the gold doubloon that Herman Melville's Captain Ahab nailed to his ship's mast as the reward to the first of his crew to sight Moby Dick. Teachers of history mention prices or wages at their peril, certain in the knowledge that someone will ask the question and equally certain that they will have a hard time answering it. We who study economic history in departments of history are expected to be able to pronounce immediately on the modern equivalent of the Biblical shekel, of medieval Venetian money, and of World War I reparations—for students and for colleagues both. Economic historians in departments of economics presumably have it easier because economists are supposed to be able to find out such things for themselves, however difficult the exercise may turn out to be. What follows is intended as a guide to all who would like to compare the changing value of things over time in real terms, at least with regard to the American economy.¹

Writers on economic matters have long recognized the need to reduce prices to constant value terms if the comparisons they wish to draw are to make any sense. They have not been equally unanimous in their choice of what to employ as the standard against which to measure the value of other things. Indeed there have been considerable differences of opinion as to what makes the best basis for such comparisons. A continuing contender has been the worth of an individual's labor. Economic theorists as different as Adam Smith, Benjamin Franklin, and Karl Marx have argued for a labor theory of value. According to Smith:

Labour . . . is the only universal, as well as the only accurate measure of value, or the only standard by which we can compare the values of different commodities at all times and at all places. We cannot estimate, it is allowed, the real value of different commodities from century to century by the quantities of silver which were given for them. We cannot estimate it year by year by the quantities of corn. By the quantities of labour we can, with the greatest accuracy, estimate it both from century to century and from year to year.²

Just as Adam Smith suggested, the two alternatives to his labor theory of value have been the value of precious metals, usually gold and silver, and the value of commodities. While the last of these, the value of commodities, has clearly won out as the accepted measure of changes in value over time, there are still those who agree with Smith that wage rates are the best deflator and there are others who prefer gold or silver. Commodity prices have the advantage of combining the value of the things that go into them, including the value of the work involved in producing them. The cost of commodities contains the value added by labor. The commodity price index has been and continues to be the preferred basis for comparing values over time.³

A commodity price index is a statistical tool designed to accomplish comparisons of real money values over time by filtering out from the data the impact of any differences in the value of money itself. The effect of using a commodity price index to answer the

question asked above is analogous to what one does using foreign exchange rates to convert foreign currencies into one's own money in order to make more comprehensible the prices of goods and services in other places. Even the calculations involved, simple division or multiplication, are much the same in both cases. The numbers produced, if only because they permit us a clearer view of the reality behind the original figures, are often referred to as the 'real' values. More usually, in comparisons of prices or trade data, we talk of the original figures as having been expressed in 'current' dollars (or pounds or yen) and the indexed prices as being expressed in 'constant' dollars (or pounds or yen).⁴

A commodity price index is only one kind of index number. Index numbers, which effectively reduce data series to percentages, may be calculated for any serial data, not just for prices. An index number 'measures the magnitude of a variable relative to a specified value,' called the reference base.⁵ We resort to the index in order to enhance our perception of changes in a series by expressing the data as a percentage of a reference base. number is the systematic expression of the percentage increases or decreases that any number in the series represents when compared against the reference base number.

Index numbers are especially useful for two purposes. They permit comparisons to be drawn among several parallel series more easily than we could from the disparate data. This is especially true when all of the index numbers are expressed in terms of reference base numbers dated to the same period. Index numbers are also useful because they transform the data in ways that allow for additional statistical analysis. Consequently they have been widely employed by economists, economic historians, and other researchers who deal with long series of numbers.

Using commodity prices to construct index numbers of the value of things has an impressive pedigree. In the eighteenth century, at least three major European political economists employed commodity price indexes in their analyses: the Englishman Bishop William Fleetwood, the Frenchman Charles Dutot, and the Italian Count Giovanni Carli.⁶ The Massachusetts General Court put theory into practice in the 1740s and again in the 1780s by legislat-

ing early forms of indexing.⁷ In the latter instance one impetus for legislative action was complaints about losses in the purchasing power of soldiers' pay caused by the depreciation in the worth of the state's currency. Similarly elsewhere over the last two centuries, episodes of sudden change in the purchasing power of money have whetted concerns about the commodity price index.⁸

The wider application of commodity price indexes has resulted in a sharpening of the theory of index numbers, a broadening in their application, more research into the history of price behavior, and the computation of more and better historical price indexes.⁹

Both economists and historians have been active in these pursuits. Historians have employed the evolving theoretical constructs of the economist in their study of early economic behavior; economists have turned to the past in order to test and refine index number theory. Significant—not only as the occasion for this paper—is the progressively earlier application of all this research, for Great Britain back into the late medieval period, for the United States now to the beginning of the eighteenth century.

The attention given to commodity price indexes has also provoked research into the best ways to compile all index numbers.¹⁰ This is especially true of index numbers that combine several elements, particularly general price indexes. The computation of a price index for a single commodity is a comparatively easy matter and involves the reduction of each value to a simple percentage of the reference base value, a 'price relative.' The computation of a general price index raises the issue of how to account for the differing degrees of importance among the various commodities

the price relatives of which are to be merged into the single index number. For instance, if an index is composed of the prices of both diamonds and wheat, we have three choices: to assign each of them equal importance (or weight); to permit them to be 'self-weighted' proportionate simply to the differences in their money costs; or to impose some scheme for apportioning between them different weights based, perhaps, on some measure of their relative significance in an economy. The realization of the first and the last of these choices requires statistical processing of the price data before the index is computed. The second option, 'self-weighting,' while making the index easier to calculate, risks possible erroneous results, such as a price index that indicates a broad rise in prices when only the price of diamonds really rose.¹¹

Compilers of modern price indexes, having the dual advantage of sufficient data and fast computers, are able to test very elaborate weighting schemes. By and large researchers have found that the best commodity price indexes are ones carefully weighted to reflect the relative importance of various commodities in an economy. Nevertheless indexes computed in all three ways tend to move roughly in tandem, changing direction at about the same time and to about the same degree. The key to the successful commodity price index rests in the choice of commodities. It is essential that one be sensitive to the 'utility value' of such commodities. As a consequence, self-weighted (or 'implicitly weighted') indexes that avoid eccentric commodities tend to be almost as good as weighted series.

Such results are reassuring to the compilers and users of historical series who rarely have enough data to construct weighted indexes and usually are forced by circumstances to adopt the weighting implicit in the differences in the magnitude of the prices themselves. Equally do we who work with historical series take comfort in the realization that commodity prices in any economy

are interdependent upon one another, that the price of flour, for instance, is a function of both the price of wheat and the costs of the labor and the machines to grind it, labor costs and machine costs being themselves influenced by the price of such things as bread. An index based on a few selected commodities can do almost as good a job of tracing the prevailing level of prices as can a weighted price index compiled from the prices of many different commodities. As one of the most important modern practitioners of the art, Earl J. Hamilton, has observed: 'Price historians have not infrequently discovered, to their dismay, at the end of a quarter century or more of assiduous labor that previously compiled index numbers based on the quotations of a very few articles—sometimes two or three—haphazardly thrown together from heterogeneous sources for widely scattered years have disclosed the trend of prices almost as accurately as their laboriously constructed indices from homogeneous series embracing monthly or quarterly quotations for dozens of commodities.'¹² The reason, according to Wesley C. Mitchell, perhaps the most important theoretician on the subject, is that 'the price changes of practically every commodity in the markets of the whole country are causally related to the changes in the prices of a few or of many, perhaps in the last resort of all, other commodities that are bought and sold.'¹³

Another issue in the compilation of price indexes has to do with the mathematics of the actual computation. First, as suggested above, the question to be asked is: does one use the prices themselves directly, totaled and divided by the reference base number—the aggregate or ‘market basket’ method; or does one first compile a price relative series for each of the commodities and take the average of the several price relatives? Then, in considering the average to be calculated, one needs to decide whether to compute an arithmetic mean or some other measure of central tendency, perhaps a geometric mean.

Again the availability of a great deal of data for the modern period has allowed index number theorists to test out all the various options. The consensus seems to be, first, that an index based on an arithmetic mean is to be preferred because the resulting series can be manipulated statistically more easily than one based on the alternatives and, second, that the aggregate or market basket index is to be preferred because it can more easily be re-computed to a new reference base number thus facilitating comparisons. Nevertheless, as Irving Fisher wrote, ‘from a practical standpoint, it is quite unnecessary to discuss the fanciful arguments for using “one formula for one purpose and another for another,” in view of the great practical fact that all methods (if free of freakishness and bias) *agree!*’¹⁴

There are two types of general price indexes produced by these methods. The wholesale commodity price index and the retail

commodity price index are intended to describe two different but closely associated sets of price movements in an economy. The former has sometimes been called, perhaps more accurately, the producers' price index in that it is an index of the prices of primary market items. It is prone to more extreme fluctuations than the retail index not only in the short run but also sometimes even over longer periods. The retail price index is better described as the index of prices paid by consumers, the consumer price index. It is also known as the cost of living index, reflecting a primary purpose in calculating it. Its movements are less volatile than the wholesale price index. This is the index more properly used to deflate such things as wage rate series in order to test the changes in the real purchasing power of wage earners or to deflate estate valuations to measure changes in real levels of wealth. Those who construct historical price indexes, while ideally using retail prices, are sometimes faced with the necessity of turning to wholesale prices. Once again we can find reassurance in the knowledge that both types of prices are and were highly correlated. Where we have the opportunity of checking, the two indexes generally move in the same direction and change directions at the same time. The results of such compromises, born of necessity, are nonetheless satisfactory.¹⁵

'Satisfactory for what purpose?' the reader may ask. Economists, historians, and economic historians have turned price indexes to two purposes. First, and most important, price indexes have been used to trace and analyze the movement of prices across time. The price index itself allows us to describe the trend in, the cycles in, and even the seasonal variations in the average levels of prices, the last provided we have monthly or quarterly data. It is also possible to utilize a commodity price index to help make better sense out of the history of the price of a single commodity. Changes in the

price of each commodity have both common causes and more specific causes. Deflating a price series of an individual commodity using the commodity price index in effect filters out what was happening generally—those conditions that affected all commodities—and places in relief just what was particular to the price history of a specific commodity. In a similar fashion, we may use the commodity price index to deflate other economic series such as import and export data, wage rates, national product figures, and so forth, in order to understand better the real directions that they took, regardless of changes in the money in which they were measured.¹⁶

It should be obvious that there are dangers inherent in any simple cross-temporal or cross-cultural comparisons that fail to pay full regard to context. For instance, annual incomes of \$25,000 in the United States today and an equivalent amount in, say, contemporary India mean considerably different things in terms of the earner's relative standard of living, social status, perhaps even political orientation.¹⁷ Similar difficulties arise with comparisons over time and, indeed, are even more of a problem for being less obvious as well as for involving the technical problems of constructing indexes that accurately reflect real price changes. What

something is or was worth has much more about it than just a mathematical answer.¹⁸

The most important ramification of the greater attention to and application of commodity price indexes as a measure of changing price levels has been in the arena of public policy. We of the late twentieth century await the monthly release of the latest commodity price index numbers with some trepidation, having been taught to read in them one of the 'vital signs' of the economy. Nations with high rates of inflation are thought to have problems with their economies while the economies of nations with low rates of inflation are considered sounder. Governments with 'problem economies' are under considerable political pressure from a concerned populace to reduce inflation.¹⁹ The commodity price index over the last two centuries has developed from a novel technique for validating price comparisons into a central element of public policy planning.

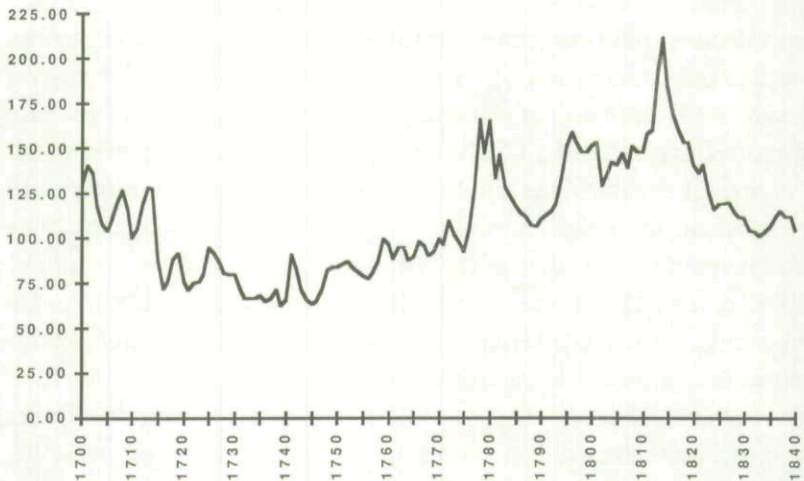
The second purpose to which commodity price indexes have been turned is one for which they were not designed and are not necessarily very well suited but a purpose which nevertheless has

been sanctioned by long usage. We frequently see the fluctuations in a commodity price index discussed and displayed as if they described the fluctuations in the performance of an economy, as if the commodity price index ran parallel to the movement of the gross national product or were some sort of surrogate for it (compare Figure 1).²⁰ No one would deny that the two are interrelated if only because the prevailing price level and the performance of the economy as a whole reflect many of the same phenomena. Yet

neither would anyone who has lived in the United States over the past generation, or in any of the other countries of the capitalist world during eras of 'stagflation,' necessarily equate rising prices with a 'good' economy. If anything, as was mentioned just above, today, when we view the commodity price index as one of the vital signs of the economy, the correlation we draw may be just the reverse of the relationship implied in this use of the commodity price index by economic historians. Nevertheless, the argument can be made that stagflation is a new economic phenomenon and that, at least before the middle of the twentieth century, periods of rising prices generally corresponded well with periods of economic growth just as periods of falling prices were periods of economic decline. In other words, we can agree that cycles in price levels paralleled the business cycle.²¹ Economic historians have indeed accepted this proposition and have relied on commodity price indexes to chart the course of the economy at least down to the time of the Great Depression and the New Deal.²²

While it is certainly necessary that any who turn to a commodity price index be alert to all of these questions, at least in the very

broad terms outlined here, we need not concern ourselves with the details of their construction or application in order to employ them. Economic historians of the modern period are fortunate in that other scholars, better equipped than they to deal with these matters, have largely sorted out the issues and have already provided us with several good price indexes. This is particularly the case for the United States for the period from the late eighteenth century to the present (see Appendix A).

It is the articulation of price indexes for the earlier period in the history of the economy of the United States that one finds the primary contribution of this paper. In addition, the better to establish the relevance of this effort, the paper sums up and brings up to date various previously published series and discusses some minor matters rising from that work. These tasks are accomplished in the tables appended to this paper, most particularly in the summary Table A-2. Finally, there seems to be some merit in trying to explain more carefully how to compute price comparisons over time, especially as they apply to the seventeenth and eighteenth centuries.

An economist may wish to know how many 1987 dollars would be required to buy a house priced at \$10,000 in 1953. To do so he or she has simply to turn to a table such as Table A-2 where, in Col. 6, one finds the commodity price index numbers for the two years in question and calculates the ratio between them ($1,359 \div 320 = 4.25$). Using that ratio as a multiplier, one can establish that, if the costs of housing had increased over the years to the same extent as all commodity prices, a house priced at \$10,000 in 1953 cost roughly \$42,500 in 1987 dollars.²³ The computation is

a simple one; the answer is mathematically sound; but the qualifying clause is all important. The result of such calculation is better considered as hypothetical rather than as definitive. In fact, because housing costs outran the average level of prices over the intervening three decades by some thirty-one percent, the kind of house that cost \$10,000 in 1953 really cost about \$55,000 in 1987.²⁴ The lesson is a valuable one not only because it exhibits one of the problems inherent in such comparisons but also because it shows the kinds of insights to be gained from their use. The commodity price index describes merely the central tendency in the movement of prices of all commodities.

Historians interested in the period before the American Revolutionary War do basically the same calculation, although with one additional step, and they must be even more cautious in their conclusions. Before the introduction of the dollar as the money of account of the new nation, the residents of each colony had their own distinct colonial currencies denominated in pounds, shillings, and pence (£1 = 20s. of 12d. each; £1 = 240d.). Because the commodity price indexes discussed herein are expressed in dollars, historians must first convert any eighteenth-century prices from pounds currency to dollars. This is most easily accomplished by reducing any sum in colonial currency to its equivalent in pounds sterling and then going from pounds sterling to dollars at the standard seventeenth- and eighteenth-century ratio of 4s.6d. sterling per dollar.²⁵ For example, in 1774, when the exchange rate was £1 35 Massachusetts currency per £100 sterling, £400 Massa-

chusetts currency was the equivalent of £296 sterling.²⁶ At £0.225 sterling per dollar, or, inversely, 4.44 dollars per one pound sterling, £296 sterling was equal to \$1,317. The two index numbers from Table A-2, Col. 6, for 1774 and 1991, are, respectively, 97 and 1,629; the ratio between them is 17 to 1; and £400 Massachusetts currency in 1774 works out to have been worth about \$22,100 United States currency in 1991.

Using the explanation just given, it is possible for anyone to convert any sum in colonial currency to its approximate dollar amount today. Table A-3 shows the results of several additional examples and serves as a means of extending the discussion a bit further. For six colonies, for four periods of peace in the eighteenth century, each of them spanning a full economic cycle from peak to peak,²⁷ Table A-3 gives the equivalent in 1991 dollars of £100 currency. We can see that, for example, on the average over the years 1766–72, £100 Pennsylvania currency was roughly the value of \$4,600 in 1991 terms. By extension, £10 Pennsylvania currency would be worth about \$460, and £1 currency \$46. If we recall that one pound equalled twenty shillings and one shilling equalled twelve pence, then we can determine that, on the eve of the American Revolutionary War, 1s. Pennsylvania currency was worth around \$2.30 in 1991 dollars and 1d. about 19¢.

Comparisons of amounts from several different periods proceed in the same fashion. To determine the comparative worth of the legacies of two individuals whose estates were probated in, for example, Massachusetts in 1755 and 1855, one has simply to perform the same kinds of calculations outlined above. The first estate was inventoried at £1,750 Massachusetts currency; the second, \$1,750. In 1755, £1,750 Massachusetts currency was the equivalent of £1,346.50 sterling or \$5,983. From Table A-2, Col. 6, where the

index numbers for 1755 and 1855 are 79 and 104, respectively, and the one for 1991 is 1,647, we can determine that \$5,983 in 1755 was equivalent to about \$123,400 in 1991 dollars and \$1,750 in 1855, equivalent to \$27,400. In real terms, the first estate was worth roughly four times the value of the second one.

The appearance of precision in all of these exercises, and, indeed, their inviting simplicity, should not obscure two important realities. We would be fortunate indeed if the data were good enough to allow us to be within ten percent of the true mathematical figure, meaning, for instance, that we can expect the actual worth of £100 Pennsylvania currency over 1766–72 to be something between \$4,140 and \$5,059 (1991).²⁸ While it is neater and computationally more convenient to use a mean rather than a range, we need to remember that a mean merely designates the central tendency within a range. Even more important, we should always remind ourselves that the mathematical answer to our question may not address all of the important issues. As with all other historical evidence, we need to evaluate it in context, we need to weight its implications in time and place, before drawing our conclusions. The price index as a deflator of money amounts over time is a tool, the 'real value' a means to an interpretative end, and never the answer in itself.

APPENDIX A

CONSUMER PRICE INDEXES, UNITED STATES,
1700-1991

THE WORK OF MANY in compiling commodity price indexes for the United States was summarized, reviewed, and amplified in a 1976 article by two eminent economists. One can only be impressed by and thankful for Paul A. David's and Peter Solar's careful construction of an index of consumer prices in the United States over the previous two hundred years. The heart of their work was their Table 1 entitled 'Index of Consumer Prices, 1774-1974'; their series is referred to by them and hereinafter as the Brady-David-Solar index and is reproduced as Col. 3 in Table A-2.²⁹ While they acknowledged some earlier studies, they did

not pay as much attention to others, notably the index generated by George Rogers Taylor and Ethel D. Hoover (hereinafter referred to as the Taylor-Hoover index) that reached back somewhat farther into the colonial era than did David and Solar themselves.³⁰ We can build on what they began.

David and Solar produced a consumer price index, as distinguished from an index of wholesale prices, in order to trace changes in the cost of living over time. Nonetheless they made the point, noted above, that there is considerable correspondence between the trends of wholesale prices and consumer prices both in their direction and in the timing of changes in direction.³¹ Moreover they found these similarities to have

been even greater in the earlier period, a fact that encouraged them, they argue, to project their index back into the colonial period relying almost exclusively on wholesale prices. 'We have therefore sought to infer the behavior of a consumer price index—which cannot really be constructed by direct means—from the observable movement of wholesale prices.'³² It is a lesson the implications of which will be applied more broadly in the present discussion.

Taylor and Hoover compiled a wholesale commodity price index for 1720–1958 based on some of the same data that David and Solar later used; it is reproduced as Col. 4 in Table A-2. One can see immediately the sense of David and Solar's point quoted above: there is an increasing correspondence between the movement of the two indexes the further back in time that one looks. This suggests that it is not unreasonable to extend the Brady-David-Solar series even earlier into the eighteenth century. It can be done using the index compiled by Anne Bezanson that appears in Col. 2. The data in the Bezanson index, like those used by David and Solar for the later period, were compiled during the 1930s in a study of Philadelphia commodity prices undertaken by Anne Bezanson and her associates. On the basis of the Bezanson index, adjusted as David and Solar themselves adjusted their later data, the series in Col. 6 establishes a composite index that reaches all the way to 1720; the two are spliced at 1774.

As was just stated, two adjustments to the Bezanson index were necessary before the linkage was accomplished. In order to establish a consumer price index from data that were wholesale prices, David and Solar introduced a correction upwards; they determined the percentage of the correction through a 'markup adjustment model.'³³ On an average over the period 1774–94, this model resulted in an increment of 8.87%. The data that are the basis of the Bezanson index were also wholesale prices and they have been adjusted here by the same percentage.

The money of account in the United States during the period of the David and Solar index was the United States dollar, the basis of which was the Spanish peso de ocho reales, the piece of eight. During the American Revolutionary War, the paper currency depreciated in worth in comparison with the silver dollar (see Appendix C). David and Solar

also took this into account for the years 1774–84 by adjusting their index by ‘an annual series of specie price relatives.’³⁴ It was necessary to do so in order that their prices would all be expressed in the same currency.

In the years before the American Revolutionary War, the money of account at Philadelphia was Pennsylvania pounds currency. An annual series of specie price relatives for the years 1720–74 was constructed on the basis of the exchange rate between Pennsylvania currency and pounds sterling. Pennsylvania currency was worth, at par, £166.67 Pennsylvania currency to £100.00 sterling. The dollar or piece of eight, was worth, at par, 4s.6d. sterling; £1 sterling was the equivalent, at par, of \$4.44. The relationship of Pennsylvania pounds currency to specie varied directly as Pennsylvania currency varied against the pound sterling. Again the two series were spliced at the year 1774. While the figures in Col. 6 for the years 1720–73 are clearly less satisfactory as a consumer price index than are those for later years, there are reasons nevertheless for thinking it not wholly unacceptable.³⁵

It is possible to extend the composite index back in time even further. Once again we can work from the same material that served as the basis of both the Bezanson index and the Brady-David-Solar index, the data collected by Anne Bezanson and her associates from Philadelphia prices. They amassed even more data than they published in their own books. Table A-1 is a compilation of some of those data, supplemented by information published elsewhere. In Table A-1 the data are organized into a commodity price index for the years 1700–20 precisely as Bezanson and Taylor-Hoover did for the later period but adjusted as above following the methods of David and Solar.³⁶

There are one or two useful lessons from Table A-1. It exhibits, perhaps all too clearly, the very limited evidence upon which eighteenth-century commodity price indexes rest. While the other, later indexes avail themselves of more commodities, the number of commodities in any index, it has been argued above, are less significant than their nature. These are the wholesale market prices of five commodities that were

central to the Pennsylvania economy at the time; they constitute an acceptable mix of imported and domestic commodities and of producers' and consumers' goods. Thus one can argue that they were reasonably representative in their own fluctuations of the movements of the other commodities in the same market. The index also exhibits the mode of calculating an aggregate or market basket index, unweighted (or, better, implicitly weighted), calculated using the arithmetic method. The index numbers appear again in Table A-2, Col. 1 and, spliced to the composite index in 1720 and recomputed to the new base period, in Col. 6.

Utilizing these same procedures, the Brady-David-Solar index in Col. 3, Table A-2, can be brought forward from 1974 through 1991, into 1992, and beyond. We accomplish this using the consumer price index compiled and published monthly and annually by the United States Bureau of Labor Statistics (see Col. 5, Table A-2). That, indeed, is the same index that David and Solar used for their index for the years 1914-74; here it is merely expanded a few more years. The reader can continue this same process by taking the monthly and annual index numbers as they are released by the Bureau of Labor Statistics and by splicing them into the series presented here.³⁷

Linking these several series is critical to constructing the long-term

index necessary for extended comparisons. The process of splicing the two Bezanson indexes and the Bureau of Labor Statistics post-1974 index into the Brady-David-Solar index is necessary because each has a different reference base period. For all the indexes to be comparable, we must convert them to the same reference base.³⁸ The base year of the Brady-David-Solar series is 1860 = 100; the Taylor-Hoover index has the period 1850-59 = 100 as its base; the first Bezanson index uses 1700-02; the second Bezanson index, 1774; the Bureau of Labor Statistics series uses 1982-84 = 100.

The method of splicing is one that simply reduces the Bureau of Labor Statistics, the Bezanson, and the Taylor-Hoover series to a new reference base year, 1860 = 100. This linkage is realized in Table A-2, Col. 6. All that had to be done to accomplish the linkage is to change the annual number for Col. 6 by the same percentage that it changes in the other columns. For instance, according to the Bureau of Labor Statistics series (Col. 5), the increase in the consumer price index in 1978 over 1977 was 7.6% ($161.2 \div 147.7 = 1.091$). On base 1860 = 100, the composite commodity price index number for 1977 is 65.2 (Col. 6); an increase of 7.6% means that in 1978 the number with reference to this base is 780 ($725 \times 1.076 = 780$). Should anyone wish to do so, a simple variation on this method will effect a change to a different reference base. One simply divides each annual number by the number for the year or years of the new reference base period.

The extension of the data in Table A-2, Col. 6, from 1700 to the present permits us to compare sums in real terms with those from any later time over almost the entire history of the United States.

APPENDIX B

CONSUMER PRICE INDEXES, GREAT BRITAIN,
1600-1991

THAT THE AMERICAN COLONISTS were subjects of Great Britain, that the economies of the colonies and the Mother Country were interconnected even interdependent, and that the economies of Great Britain and the United States continued to have a 'special relationship' down into the late twentieth century suggest a possible comparative element to any discussion of the commodity price index in the United States from the first days of the colonial period down to the present.

There are even more commodity price indexes for Great Britain than there are for the United States.³⁹ Again, however, others have done the job of sorting through them for us and selected those most useful for historical purposes.⁴⁰ If only because it was compiled on the same basis for so long a period and, as a result, satisfies the important criterion of consistency over such a long time, the index of English commodity prices used by most economic historians is the one generated by Ernest H. Phelps Brown and Sheila V. Hopkins. In compiling their index for the early period, Phelps Brown and Hopkins used the price data assembled during the 1930s by Lord Beveridge and his colleagues for the English price history project; for the last two centuries they relied more on the work of others. Their index spanned seven centuries from 1264 to 1954 on a reference base 1451-75 = 100; for the period 1600 to 1954, it is reproduced here in Table B-1, Col. 1.⁴¹ For a comparison with another

eighteenth-century commodity price index (reference base 1700=100), see the one by Elizabeth Boody Schumpeter and Elizabeth W. Gilboy as reproduced in Col. 2, Table B-1.⁴²

It is possible to splice the Phelps Brown-Hopkins index into a retail price index compiled monthly by the Department of Employment and consequently to extend the British consumer price index down to the present. The original series on a reference base 1967=100 is reproduced here in Table B-1, Col. 3.⁴³ Table B-1, Col. 4, is a composite index combining the Phelps Brown-Hopkins series and the Department of Employment series. Linkage is accomplished at 1954. The reference base for Col. 4 is the same as that for Table A-2, Col. 6, 1860=100.

An intriguing question for economic historians of early America is just how closely do the index numbers in Table B-1, Col. 4, correlate with those in Table A-2, Col. 6. The answer is: quite well indeed. For the period 1700 to 1790 the two moved in parallel tracks. They changed direction at roughly the same times and to roughly the same degree. Such parallels continued to operate through the nineteenth and into the twentieth centuries. Indeed, given the close connections between the two economies and the workings of such mechanisms as commercial and financial arbitrage, these parallels are to be expected, especially during the Old Empire.⁴⁴

The parallels between the colonial and the British price indexes suggest three things. First, each index gains in credibility. The data for both commodity price indexes and, thus, the index numbers themselves are sound and can be relied upon as reasonably accurate in their depiction of the movement of commodity prices in each place. Second, our appreciation of the reality of the close connections among the economies along the Atlantic rim is buttressed. The British and the British colonial economies were clearly interrelated. The colonists were integrally tied to the Atlantic economy of which Great Britain, by the middle of the eighteenth century, was the leader.⁴⁵ Finally, the parallels of the eighteenth century and later suggest that the fluctuations expressed by the British commodity price index in the seventeenth century probably described colonial price movements fairly well during that century also, a period for which we do not yet have published adequate colonial commodity price indexes. One implication of all of these suggestions is explored more fully in Appendix D.

APPENDIX C

AMERICAN REVOLUTIONARY WAR CURRENCY
DEPRECIATION TABLES

BECAUSE the depreciation in the purchasing power of the currency of the American Revolutionary War period was such a concern for contemporaries and because it is such a cause of confusion for historians, it is worth establishing the relationship between that currency and the commodity price index.

Just as they had done as colonies, during the American Revolutionary War period the various states of the United States issued paper money to be used as currency. So also did the central government, the Continental Congress.⁴⁶ The common unit of account for all these currencies was the dollar. Even though several of the states denominated their own paper monies in the old notation, all were established at a fixed, unvarying ratio to the new, national dollar.⁴⁷ At first the paper dollars of the Continental Congress and the states passed, as they were supposed to pass, as the equivalent to the coin after which they were named. One paper dollar was the same as one hard, silver dollar. That dollar, of course, was the Spanish piece of eight.

The problems of war soon changed all that. Paper money began to lose its worth; people came to value it less than they valued the silver dollar. Everyone quickly learned to demand and to pay more in paper currency than they did in hard currency. What cost \$2.00 if you paid in silver, cost \$3.00 and then \$4.00 if you tried to pay with paper money. As the gap between the two widened, it became increasingly necessary to specify and to record the difference. So much was the paper money issued by the Continental Congress (the 'Continental') found to be unacceptable that people rarely used it for accounting purposes and preferred instead to continue to price goods and services either in hard silver dollars or in their old colonial moneys of account.⁴⁸ Compounding the consequent difficulties, each state's paper money behaved somewhat differently from that issued by its neighbors and from Congress's 'Continental'. As confusion bred chaos, Congress finally acted and declared that, as of mid-March 1780, the old paper money would no longer be recognized as legal tender currency in the country. While some of it continued to circulate in daily transactions—and indeed continued in some places to depreciate in its worth, after mid-1780 prices and wages could legally be expressed only in the new United States dollars.⁴⁹

The data in Table C-1 and Table C-2 replicate contemporary tables of the depreciation of the wartime paper money against silver dollars.⁵⁰

For instance, according to these tables, by December 1778, it took 600 Pennsylvania paper dollars or 681 Continental paper dollars to buy what was worth 100 silver dollars. Recall that the fluctuations recorded in the commodity price index in Table A-2, Col. 6, are expressed in hard dollars. Thus it is necessary to convert a sum stated in Pennsylvania paper money (or any of the other paper monies in use at the time) to silver dollars using Table C-1 before reducing it to any constant value using the commodity price index in Table A-2.

APPENDIX D

PERIODS OF EXPANSION AND CONTRACTION IN
THE ECONOMY OF EARLY AMERICA, 1701-1838

COMMODITY PRICE DATA may be used to help identify the phases of the business cycle, at least up to the beginning of the Second World War, as was discussed above. The index numbers in Table A-2, Col. 6, for the eighteenth century and early nineteenth century are the basis of both Table D-1 and Figure 1. Between 1701 and 1836 there were twenty-four full cycles of contraction and expansion. The average cycle lasted just over five-and-a-half years, peak to peak.⁵¹ The trend line over the eighteenth century indicates, first, a long-term decline that had its beginnings in the seventeenth century and reached its nadir during the 1730s; and, second, a subsequent steady rise that continued on into the nineteenth century. Both the fluctuations and the trends in the business cycle of the early American economy were paralleled by the fluctuations and trends in the economy of Great Britain (see Appendix B).⁵²
