USER TERMS OF SERVICE

1. INTRODUCTION

These User Terms of Service (these “Terms”) govern your access to and use of products, services and properties made available by Art Blocks, Inc. (“Art Blocks,” “we,” “us” or “our”). Our products, services and properties include, without limitation, the creation, purchase, sale, exchange, or modification of certain digital assets; our online and/or mobile services via such channels, including the website available at <https://artblocks.io/>, and software provided on, or in connection with, those services (collectively, the “Service”). Certain features of the Service are subject to additional guidelines, terms, or rules, including, but not limited to, our policies regarding privacy, use of cookies, and other terms that may be implemented from time to time (“Supplemental Terms”), applicable to your use of each such feature. All such Supplemental Terms are incorporated by reference into these Terms. If these Terms are inconsistent with any Supplemental Terms, the Supplemental Terms shall control solely with respect to such features of the Service.

ART BLOCKS OFFERS A PLATFORM FOR CREATORS, BUYERS AND SELLERS OF DIGITAL ASSETS AND ANY NON-DIGITAL PRODUCTS, SERVICES AND/OR BENEFITS TO BE FURNISHED BY OR ON BEHALF OF SELLERS IN CONNECTION WITH SUCH SALES. WE ARE NOT A BROKER, FINANCIAL INSTITUTION, OR CREDITOR. THE SERVICE IS AN ADMINISTRATIVE PLATFORM ONLY. ART BLOCKS FACILITATES TRANSACTIONS BETWEEN THE BUYER AND SELLER BUT IS NOT A PARTY TO ANY AGREEMENT BETWEEN THE BUYER AND SELLER OR OTHERWISE BETWEEN ANY USERS OF THE SERVICE. YOU SPECIFICALLY ACKNOWLEDGE AND AGREE THAT, IF YOU USE THE SERVICE TO MAKE A PURCHASE, THE SELLER SHALL BE AN INTENDED THIRD-PARTY BENEFICIARY OF THESE TERMS WITH RESPECT TO THE ITEM(S) (AS DEFINED BELOW) SOLD AND SELLER’S RIGHTS WITH RESPECT THERETO. PURSUE CLAIMS AND SEEK RELIEF AGAINST US ON AN INDIVIDUAL BASIS, NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY CLASS OR REPRESENTATIVE ACTION OR PROCEEDING; AND (2) YOU ARE AGREEING TO MANDATORY INDIVIDUAL ARBITRATION FOR THE RESOLUTION OF DISPUTES AND WAIVING YOUR RIGHT TO A JURY TRIAL OR BENCH TRIAL ON YOUR CLAIMS.

PLEASE BE AWARE THAT SECTION 7 OF THESE TERMS CONTAINS YOUR DEFAULT OPT-IN CONSENT TO RECEIVE COMMUNICATIONS FROM US.

THESE TERMS ARE IMPORTANT AND AFFECT YOUR LEGAL RIGHTS, SO PLEASE READ THEM CAREFULLY. BY CLICKING ON ANY “I ACCEPT” BUTTON, COMPLETING THE ACCOUNT REGISTRATION PROCESS, SELLING OR PURCHASING ITEMS THROUGH THE SERVICE, AND/OR OTHERWISE USING THE SERVICE, YOU AGREE TO BE BOUND BY THESE TERMS AND ALL OF THE TERMS INCORPORATED HEREIN BY REFERENCE. By submitting data through the Service, you expressly consent to the collection, use and disclosure of your personal data in accordance with the Privacy Policy.

Art Blocks reserves the right to change or modify these Terms at any time and in our sole discretion. If we make changes to these Terms, we will provide notice of such changes, such as by sending an email notification, or providing notice through the Service or updating the “Last Updated” date at the beginning of these Terms. By continuing to access or use the Service at any point after such update, you confirm your acceptance of the revised Terms and all of the provisions incorporated therein by reference. You should review these Terms frequently to ensure that you understand the terms and conditions that apply when you access or use the Service. If you do not agree to the revised Terms, you may not access or use the Service.

2. OUR SERVICE

a. The Service is a software application made available by Art Blocks to enable users of the Service (“Users”) to Mint (as defined below), sell, and purchase unique non-fungible tokens and any non-digital products, services and/or benefits to be furnished by or on behalf of sellers in connection with such sales and purchases (collectively, the “Items” or individually an “Item”), implemented on the Ethereum Blockchain platform (the “Blockchain Platform”) using smart contracts. You may only participate in the Minting, purchase, or sale of any Item by linking an Ethereum digital wallet that allows you to purchase, store, and engage in transactions using cryptocurrency (each, a “Digital Wallet”) on supported bridge extensions. Before purchasing an Item, you must download a supported Digital Wallet bridge extension and use such extension to connect and unlock your Digital Wallet through the Service. Once you submit an order to Mint or purchase an Item, your order is passed on to the applicable extension, which completes the transaction on your behalf.

b. ALL TRANSACTIONS INITIATED THROUGH OUR SERVICE ARE EXECUTED BY THIRD-PARTY DIGITAL WALLET EXTENSIONS. BY USING OUR SERVICES, YOU AGREE THAT SUCH

TRANSACTIONS ARE GOVERNED BY THE TERMS OF SERVICE AND PRIVACY POLICY FOR THE APPLICABLE EXTENSIONS.

3. **USER REPRESENTATIONS AND WARRANTIES**

a. You must be at least eighteen (18) years old to use the Service. By using the Service to Mint, purchase, list, or sell an Item, as applicable, you agree to (i) provide accurate, current, and complete information about yourself, (ii) maintain and promptly update from time to time as necessary such information, (iii) maintain the security of your Digital Wallet and accept all risks of unauthorized access to your Digital Wallet and to the information you provide to us, and (iv) immediately notify us if you discover or otherwise suspect any security breaches related to the Service.

b. You agree that you will not: (i) buy, sell, rent, or lease access to the Services without our written permission; (ii) log in or try to log in to access the Service through unauthorized third-party applications or clients.

c. Art Blocks may require you to provide additional information and documents at the request of any competent authority or to assist Art Blocks in its compliance with applicable law, regulation, or policy, including laws designed to prevent legalization of incomes obtained by criminal means or financing of terrorism. Art Blocks will require you to provide additional information and documents in cases where it has reasons to believe that:

- i. Your Digital Wallet or other access to the Service is being used for money laundering or for other illegal activity;
- ii. You have concealed or reported false identification information and other details; or
- iii. Transactions executed via your Digital Wallet were executed in breach of these Terms.

In such cases, Art Blocks, in its sole discretion, may pause or cancel your transactions until such requested additional information and documents have been reviewed by Art Blocks and accepted as satisfying the requirements of applicable law, regulation, or policy. If you do not provide complete and accurate information and documents in response to such a request, Art Blocks may refuse to provide to you; any Item, Content (as defined below), product, service or further access to the Service.

d. When you use the Service to Mint, purchase, list, or sell an Item, you hereby represent and warrant, to and for the benefit of Art Blocks, its affiliates and its and their respective representatives, as follows:

i. **Authority.** You have all requisite capacity, power and authority to enter into, and perform your obligations under these Terms, including to Mint, sell, list, or buy any Items, as applicable. The execution, delivery and performance of, and the performance of your obligations under these Terms have been duly authorized by all necessary action on your part, if you are an entity by such entity's board of directors or comparable governing authority(ies), and no other proceedings on your part or any other person or entity are necessary to authorize the execution, delivery or performance by you of your obligations under these Terms.

ii. Due Execution; Validity. These Terms constitute your legal, valid, and binding obligation enforceable against you in accordance with these Terms.

iii. Accuracy of Background Check Information. All information provided by you or on your behalf to Art Blocks and/or its third-party designees, including any address and social security number or tax ID number, each is accurate and complete. You further represent that you; any of your affiliates; any other person having a common economic or beneficial interest with you, or if you are an entity, in you; or any person or entity for whom you are acting as agent or nominee in connection with these Terms is not: (A) a country, territory, entity or individual named on an Office of Foreign Assets Control of the United States Treasury Department (“OFAC”) list as provided and updated from time to time at <http://www.treas.gov/ofac>, or a Person or entity prohibited under the OFAC programs, regardless of whether or not they appear on the OFAC list; nor (B) a senior foreign political figure, or any immediate family member or close associate of a senior foreign political figure.

iv. Non-Contravention. These Terms do not, and the performance of your obligations under these Terms and your Minting, listing, buying, or selling of any Items, as applicable to your use of the Service, will not: (A) if you are an entity, conflict with or violate any of the organizational documents of such entity or any resolution adopted by its equity holders or other persons having governance or management authority over the entity; (B) contravene, conflict with or violate any right of any third party or any applicable legal requirement to which you or any of the assets owned or used by you, each is subject; or (C) result in any breach of or constitute a default (or an event that with notice or lapse of time or both would become a default) under any material contract or agreement to which you are a party or by which you are bound, any license, permit or similar right held by you, or any legal requirement applicable to you.

v. Independent Investigation and Non-Reliance. You are sophisticated, experienced and knowledgeable in the Minting, listing, buying, or selling of any Items, as applicable. Additionally, you have conducted an independent investigation of the Service and the matters contemplated by these Terms, have formed your own independent judgment regarding the benefits and risks of and necessary and desirable practices regarding the foregoing, and, in making the determination to Mint, list, buy, or sell any Items using the Service, you have relied solely on the results of such investigation and such independent judgement. Without limiting the generality of the foregoing, you understand, acknowledge and agree that the legal requirements pertaining to blockchain technologies and digital assets generally, including the Items, are uncertain and involve a high degree of risk, and you have conducted an independent investigation of such potentially applicable legal requirements and the resulting risks and uncertainties, including the risk that one or more governmental entities or other persons may assert that any digital assets or cryptographic tokens (including the Items) may constitute securities under applicable legal requirements potentially subjecting same to stringent regulatory requirements applicable to transactions involving securities. You hereby irrevocably disclaim and disavow reliance upon any statements or representations made by or on behalf of, or information made available by, Art Blocks, in deciding to enter into these Terms, Mint, list, buy, or sell any Items or use the Service.

vi. Litigation. There is no legal proceeding pending or threatened that relates to your activities relating to the Minting of Items or other token or digital asset trading or blockchain technology related activities.

vii. Compliance. You have not failed to comply with, and have not violated, any applicable legal requirement relating to any blockchain technologies, token trading activities or Minting Items. No investigation or review by any governmental entity is pending or has been threatened against or with respect to you, nor does any government order or action prohibit you or any of your affiliates or representatives from engaging in or continuing any conduct, activity or practice relating to Minting Items.

e. You are solely responsible for providing all equipment and software necessary to connect to the Service. You are also solely responsible for any fees, including internet connection or mobile fees, that you incur when accessing the Service, including any gas fees or other fees or costs related to accessing and utilizing any blockchain technology.

4. ACCOUNT REGISTRATION

To use certain features of the Service you may need to register for an account on the Service (“Account”). You must be at least eighteen (18) years old to register for an Account. By creating an Account, you agree to: (i) provide accurate, current, and complete Account information about yourself; (ii) maintain and promptly update from time to time as necessary your Account information; (iii) maintain the security of your password and of any device used for multi-factor authentication, and accept all risks of unauthorized access to your Account; and (iv) immediately notify us if you discover or otherwise suspect any unauthorized access or other security breaches related to the Service or your Account. Art Blocks reserves the right to block any Accounts, including multiple Accounts of the same user, or deny, ban, cancel any Accounts at any time, for any reason. By creating an Account, you agree to comply with all applicable laws and regulations in connection with your use of the Account, including without limitation, compliance with any import/export laws and regulations. You are responsible for any cost associated with the creation and use of your Account, including any cost associated with accessing your Account on whatever device you choose to access your Account or the Services.

5. MINTING AN ITEM

a. A creator of generative art (“Creator”) may upload a script containing or embodying an algorithm (each such script, “Creator IP”) to the Blockchain Platform. Users may be able to use the Service to generate or issue (“Mint”) on the Blockchain Platform an Item generated by the Creator IP. By Minting or purchasing or selling (or by offering to purchase or sell) an Item, you agree to comply with any terms, including licenses or payment rights that are embedded within or otherwise included with any Item that you Mint, sell or purchase. Art Blocks does not guarantee that Items Minted on the Service will be transferable to any other platform. You acknowledge and agree that, when you Mint an Item, you do not expect to receive and do not receive any rights to the algorithm comprising Creator IP.

b. The Creator of any Creator IP may designate at point of upload and Art Blocks will display at the point of sale: (i) how many Items may be Minted through the Service from each instance of Creator IP; (ii) provided same comply with applicable legal requirements which Creator certify to Art Blocks is in compliance with applicable law, the terms of the license in the Creator IP that is granted to the User who Mints an Item using such Creator IP or any subsequent owners of such Item; and (iii) any fee payable in connection with any subsequent sale of an Item generated by Creator IP (each such sale, a “Secondary Sale,” and such fee, a “Secondary Sale Fee”). You hereby represent and warrant to Art Blocks that you are

the legal owner of Creator IP and the same does not and will not violate any other party's intellectual property or similar rights.

c. The Service is only a marketplace, and Art Blocks is not and shall not be a party to any transaction or dispute between any Creator of Creator IP and any Minter or subsequent owner of an Item generated by that Creator's Creator IP, whether arising from any rights granted in that Item or otherwise.

6. PRICING AND FEES; PAYMENTS

a. All pricing and payment terms for Items are as indicated at point of sale or otherwise on the Service, and any payment obligations you incur are binding at the time of purchase. You may not substitute any other currency, whether cryptocurrency or fiat currency, for the currency in which you have contracted to pay at the time of purchase. For clarity, no fluctuation in the value of any currency, whether cryptocurrency or otherwise, shall impact or excuse your obligations with respect to any purchase. Creators use a variety of methods to sell Items, and in the event any funds paid need to be remitted to you as a result of the settlement resulting from such sale (ie. Sale via Dutch auction), it is your responsibility to claim any funds through the use of the minter contract associated with the sale.

b. When you Mint an Item, you agree that you have read, understood, and agreed to be bound by any terms and conditions applicable to the Secondary Sale of that Item, including any Secondary Sale Fee (regardless of whether such Secondary Sale Fee is enforced or supported by the third-party platform or marketplace that facilitates a Secondary Sale). You further agree that it is your responsibility to ensure that you must bind any subsequent purchaser of the Item to such Secondary Sale terms and conditions.

c. Art Blocks may add or change any payment processing services at any time. Such services may be subject to additional terms or conditions. Whether a particular cryptocurrency is accepted as a payment method by Art Blocks is subject to change at any time in Art Blocks' sole discretion.

7. CONSENT TO ELECTRONIC COMMUNICATION

By providing Art Blocks with your email address or by using the Service to Mint, purchase, list, or sell an Item, you consent to receive electronic communications from Art Blocks (e.g., via email or by posting notices to the Service). These communications may include notices about your use of the Service (e.g., transactional information) and are an integral part of your relationship with us. You agree that any notices, agreements, disclosures, or other communications that we send to you electronically will be deemed to satisfy any applicable legal communication requirements, including, but not limited to, that such communications be in writing. You should maintain copies of electronic communications from us by printing a paper copy or saving an electronic copy. We have no obligation to store for your later use or access any such electronic communications that we make to you. We may also send you promotional communications via email, including, but not limited to, newsletters, special offers, surveys and other news and information we think will be of interest to you. You may opt out of receiving these promotional emails at any time by following the unsubscribe instructions provided therein.

8. OWNERSHIP

- a. Unless otherwise indicated in writing by us, the Service and all content and other materials contained therein, including, without limitation, the Art Blocks logo and all designs, text, graphics, pictures, information, data, software, sound files, other files and the selection and arrangement thereof (collectively, “Content”) are the intellectual property of Art Blocks or our affiliates, licensors or Users, as applicable.
- b. Notwithstanding anything to the contrary in these Terms, the Service and Content may include software components provided by Art Blocks or its affiliates or a third party that are subject to separate license terms, in which case those license terms will govern such software components and same are deemed incorporated herein by this reference.
- c. The Art Blocks logo and any Art Blocks product or service names, logos or slogans that may appear on the Service are trademarks of Art Blocks or our affiliates and may not be copied, imitated or used, in whole or in part, without our prior written permission. You may not use any metatags or other “hidden text” utilizing “Art Blocks,” or any other name, trademark or product or service name of Art Blocks (including without limitation any derivative thereof) or our affiliates without our prior written permission. In addition, the look and feel of the Service and Content, including, without limitation, all page headers, custom graphics, button icons and scripts, constitute the service mark, trademark or trade dress of Art Blocks (including without limitation any derivative thereof) and may not be copied, imitated or used, in whole or in part, without our prior written permission. - f. Develop, utilize, or disseminate any software, or interact with any application programming interface ("API") in any manner, that could damage, harm, or impair the Service;
- g. Reverse engineer any aspect of the Service, or do anything that might discover source code or bypass or circumvent measures employed to prevent or limit access to any service, area, or code of the Service;

- j. Collect or harvest data from our Service that would allow you to contact individuals, companies, or other persons or entities, or use any such data to contact such entities;

a. **Applicability of Arbitration Agreement.** You agree that all claims and disputes (excluding claims for injunctive or other equitable relief as set forth below) in connection with these Terms, or the use of any Service that cannot be resolved informally or in small claims court shall be resolved by binding arbitration on an individual basis under the terms of this Arbitration Agreement. Unless otherwise agreed to, all arbitration proceedings shall be held in English. This Arbitration Agreement applies to you and Art Blocks, and to any subsidiaries, affiliates, agents, employees, predecessors in interest, successors, and assigns, as well as all authorized or unauthorized users or beneficiaries of services or goods provided under these Terms.

b. **Notice Requirement and Informal Dispute Resolution.** Before either party may seek arbitration, the party must first send to the other party a written notice describing the nature and basis of the claim or dispute and the requested relief (“Notice of Dispute”). A Notice of Dispute to Art Blocks should be sent to: legal@artblocks.io. After the Notice of Dispute is received, you and Art Blocks may attempt to resolve the claim or dispute informally. If you and Art Blocks do not resolve the claim or dispute within thirty (30) days after the Notice of Dispute is received, either party may begin an arbitration proceeding. The amount of any settlement offer made by any party may not be disclosed to the arbitrator until after the arbitrator has determined the amount of the award, if any, to which either party is entitled.

c. **Arbitration Rules.** Arbitration shall be initiated through the American Arbitration Association (“AAA”), an established and reputable alternative dispute resolution provider (“ADR Provider”) that offers arbitration as set forth in this section. If AAA is not available to arbitrate, the parties shall agree to select an alternative ADR Provider. The rules of the ADR Provider shall govern all aspects of the arbitration, including but not limited to the method of initiating and/or demanding arbitration, except to the extent such rules are in conflict with these Terms. The AAA Consumer Arbitration Rules (“Arbitration Rules”) governing the arbitration are available online at www.adr.org or by calling the AAA at 1-800-778-7879. The arbitration shall be conducted by a single, neutral arbitrator and the internal laws of the State of Texas shall apply to all matters subject of the arbitration. Any claims or disputes where the total amount of the award sought is less than Ten Thousand U.S. Dollars (US \$10,000.00) may be resolved through binding non-appearance-based arbitration, at the option of the party seeking relief. For claims or disputes where the total amount of the award sought is Ten Thousand U.S. Dollars (US \$10,000.00) or more, the right to a hearing will be determined by the Arbitration Rules. Any hearing will be held in a location within 100 miles of your residence, unless you reside outside of the United States, and unless the parties agree otherwise. If you reside outside of the U.S., any oral hearing required shall be held in Houston, Harris County, Texas and the arbitrator shall give the parties reasonable notice of the date, time and place of any oral hearings. Any judgment on the award rendered by the arbitrator may be entered in any court of competent jurisdiction. If the arbitrator grants you an award that is greater than the last settlement offer that Art Blocks made to you prior to the initiation of arbitration, Art Blocks will pay you the greater of the award or \$2,500.00. Each party shall bear its own costs (including attorney’s fees) and disbursements arising out of the arbitration and shall pay an equal share of the fees and costs of the ADR Provider.

d. Additional Rules for Non-Appearance Based Arbitration. If non-appearance based arbitration is elected, the arbitration shall be conducted by telephone, online and/or based solely on written submissions; the specific manner shall be chosen by the party initiating the arbitration. The arbitration shall not involve any personal appearance by the parties or witnesses unless otherwise agreed by the parties.

e. Time Limits. If you or Art Blocks pursues arbitration, the arbitration action must be initiated and/or demanded within the statute of limitations (i.e., the legal deadline for filing a claim) and within any deadline imposed under the AAA Rules for the pertinent claim.

f. Authority of Arbitrator. If arbitration is initiated, the arbitrator will decide the rights and liabilities, if any, of you and Art Blocks, and the dispute will not be consolidated with any other matters or joined with any other cases or parties. The arbitrator shall have exclusive authority to: (i) determine the scope and enforceability of this Arbitration Agreement; and (ii) resolve any dispute related to the interpretation, applicability, enforceability or formation of this Arbitration Agreement including, but not limited to, any claim that all or any part of this Arbitration Agreement is void or voidable; and shall also have the authority to grant motions dispositive of all or part of any claim. The exceptions to the preceding sentence are: (1) all disputes arising out of or relating to the class action waiver, including any claim that all or part of the class action waiver is unenforceable, illegal, void or voidable, or such class action waiver has been breached, shall be decided by a court of competent jurisdiction and not by an arbitrator; (2) all disputes arising out of or relating to the payment of arbitration fees shall be decided only by a court of competent jurisdiction and not by an arbitrator; and (3) all disputes arising out of or relating to whether either party has satisfied any condition precedent to arbitration shall be decided only by a court of competent jurisdiction and not by an arbitrator. The arbitrator shall have the authority to award monetary damages, and to grant any non-monetary remedy or relief available to an individual under applicable law, the AAA Rules, and these Terms. The arbitrator shall issue a written award and statement of decision describing the essential findings and conclusions on which the award is based, including the calculation of any damages awarded. The arbitrator has the same authority to award relief on an individual basis that a judge in a court of law would have. The award of the arbitrator is final and binding upon you and Art Blocks. Any judgment on the award rendered by the arbitrator may be entered in any court of competent jurisdiction.

g. Waiver of Jury Trial. THE PARTIES HEREBY WAIVE THEIR CONSTITUTIONAL AND STATUTORY RIGHTS TO GO TO COURT AND HAVE A TRIAL IN FRONT OF A JUDGE OR A JURY, instead electing that all claims and disputes shall be resolved by arbitration under this Arbitration Agreement. Arbitration procedures are typically more limited, more efficient and less costly than rules applicable in a court and are subject to very limited review by a court. In the event any litigation should arise between you and Art Blocks in any state or federal court in a suit to vacate or enforce an arbitration award or otherwise, YOU AND ART BLOCKS WAIVE ALL RIGHTS TO A JURY TRIAL, instead electing that the dispute be resolved by a judge located in Harris County, Texas.

h. Waiver of Class or Consolidated Actions. ALL CLAIMS AND DISPUTES WITHIN THE SCOPE OF THIS ARBITRATION AGREEMENT MUST BE ARBITRATED OR LITIGATED ON AN INDIVIDUAL BASIS AND NOT ON A CLASS BASIS, AND CLAIMS OF MORE THAN ONE CUSTOMER OR USER CANNOT BE ARBITRATED OR LITIGATED JOINTLY OR CONSOLIDATED WITH THOSE OF ANY OTHER CUSTOMER OR USER. If a decision is issued stating that applicable law precludes enforcement of any of this subsection's limitations as to a given claim for relief, then the

claim must be severed from the arbitration and brought into the federal or state court located in Harris County, Texas. All other claims shall be arbitrated.

i. Confidentiality. All aspects of the arbitration proceeding, including but not limited to the award of the arbitrator and compliance therewith, shall be strictly confidential. The parties agree to maintain confidentiality unless otherwise required by law. This paragraph shall not prevent a party from submitting to a court of law any information necessary to enforce this Agreement, to enforce an arbitration award, or to seek injunctive or equitable relief.

j. Severability. If any part or parts of this Arbitration Agreement are found under the law to be invalid or unenforceable by a court of competent jurisdiction, then such specific part or parts shall be of no force and effect and shall be severed and the remainder of the Arbitration Agreement shall continue in full force and effect.

k. Right to Opt Out. You have the right to opt out of this Arbitration Agreement by sending written notice of your decision to opt out to: **legal@artblocks.io**. Such notice must be given within 30 days after first becoming subject to a version of these Terms containing an arbitration provision. Your notice must include your name and address, your Digital Wallet, the email address you used to interact with the Service, and an unequivocal statement that you want to opt out of this Arbitration Agreement. If you opt out of arbitration, all other parts of these Terms will continue to apply to you. Opting out of arbitration has no effect on any other arbitration agreements that you may currently have, or may enter into in the future, with us.

l. Right to Waive. Any or all of the rights and limitations set forth in this Arbitration Agreement may be waived by the party against whom the claim is asserted. Such waiver shall not waive or affect any other portion of this Arbitration Agreement.

m. Survival of Agreement. This Arbitration Agreement will survive the termination of your relationship with Art Blocks.

n. Small Claims Court. Notwithstanding the foregoing, either you or Art Blocks may bring an individual action in small claims court.

o. Emergency Equitable Relief. Notwithstanding the foregoing, either party may seek emergency equitable relief before a state or federal court in order to maintain the status quo pending arbitration. A request for interim measures shall not be deemed a waiver of any other rights or obligations under this Arbitration Agreement.

p. Claims Not Subject to Arbitration. Notwithstanding the foregoing, claims of defamation, violation of the Computer Fraud and Abuse Act, and infringement or misappropriation of the other party's patent, copyright, trademark or trade secrets shall not be subject to this Arbitration Agreement.

q. Courts. In any circumstances where the foregoing Arbitration Agreement permits the parties to litigate in court, the parties hereby agree to submit to the personal jurisdiction of the courts located within Harris County, Texas for such purpose.

22. **GENERAL**

We reserve the right in our sole discretion to modify, suspend, or discontinue the Service, or any features or parts thereof, whether temporarily or permanently, at any time with or without notice to you in our sole discretion. These Terms, and your access to and use of the Service, shall be governed by and construed and enforced in accordance with the laws of the State of Texas, without regard to any conflict of law rules or principles that would cause the application of the laws of any other jurisdiction. Any dispute between the parties that is not subject to arbitration or cannot be heard in small claims court, shall be resolved in the state or federal courts of Houston, Harris County, Texas. Notwithstanding anything contained in these Terms, we reserve the right, without notice and in our sole discretion, to terminate your right to access or use the Service at any time and for any or no reason, and you acknowledge and agree that we shall have no liability or obligation to you in such event and that you will not be entitled to a refund of any amounts that you have already paid to us, to the fullest extent permitted by applicable law. If any term, clause or provision of these Terms is held invalid or unenforceable, then that term, clause or provision will be severable from these Terms and will not affect the validity or enforceability of any remaining part of that term, clause or provision, or any other term, clause or provision of these Terms. Your relationship to Art Blocks is that of an independent contractor, and neither party is an agent or partner of the other. These Terms, and any rights and licenses granted hereunder, may not be transferred or assigned by you without the prior written consent of Art Blocks. Art Blocks' failure to assert any right or provision under these Terms shall not constitute a waiver of such right or provision. Except as otherwise provided herein, these Terms are intended solely for the benefit of Art Blocks and you and are not intended to confer third party beneficiary rights upon any other person or entity.
